### Abortion Clinics Given Higher Medical Standards

Tuesday, the House of Delegates passed [HB 393](#) by a vote of [72-25](#). Patroned by Delegate Matt Lohr (R-26 Harrisonburg), HB 393 would put unregulated abortion centers under three simple regulations: licensure, an annual inspection, and they would be required to have lifesaving equipment on premises, such as defibrillators.
